Once a week is deposited with RCI it cannot be taken back. It is the owner's responsibility to contact RCI with their deposits. If an Owner's Calendar is not returned within 30 days of receipt the owner's weeks are automatically defaulted into the rental pool. In order to take advantage of space available privileges, manager requires that one week per year be available for rental in summer (June 1-Sept 30) or winter (Dec 15-Apr 15) seasons. There is a \$40 Reservation Fee for each owner week used and a \$10 Reservation Fee for each Space Available Reservation.
